# Outlook esearch

Issue 1 of "Research Outlook" in November 2010 was a fine step forward in the development of ICL Business School's research culture. The ICL Research Advisory Board, which met on 6<sup>th</sup> December, chaired by Dr John Hinchcliff, encouraged staff to undertake both group and individual research projects and also to seek the outside involvement of research advisors. I am pleased to announce that we are already in discussions with the NZ Institute of Management as a potential research partner and other activities including conference activities are underway.

Recent activities led by Dayal Talukder, include presenting papers from his soon to be submitted PhD thesis to ICL staff in a seminar, and to the 7th International Sustainability Conference held last month at the University of Waikato. Our most urgent priority now is to establish an Ethics Committee to facilitate primary research. This should be in place in time for the first School-sponsored project of the year starting in March.

Although there is a business focus in our current development projects we are also looking closely at Education. ICL has recently qualified for government funding of its Early Childhood Education programme and we are looking forward to recruiting 40 domestic students this year. A project we have had in mind for some time is a comparative study of domestic and international student graduate outcomes; so the availability of domestic students now enables us to undertake such a project internally.

A business school is as dynamic as its staff, and we are pleased to have welcomed over the last few months new lecturers who bring our tally of doctorate-qualified staff up to four. All told our lecturers now share four doctorates, 20 masters, 21 bachelors and 28 graduate or post graduate certificates and diplomas. While teaching will always be our primary activity, it is encouraging to observe the rise of research.

### Research Plans at ICL

Staff and students at ICL Business School are involved in active research. Students already have to conduct research in the form of writing assessments and reports covering anything between 30% and 100% of the total course assignment. Academic staff are extensively engaged in supervising students to complete their assignments successfully.

### Current Research Activities

ICL has been publishing its research newsletter – **Research Outlook** since November 2010. This publication assists with ICL's ambition to create a research environment at ICL. It is intended to publish **Research Outlook** regularly.

ICL has already introduced **Monthly Research Seminars**. Staff are encouraged to present their research works in this seminar. In November 2010, Dayal Talukder, a Business Lecturer presented the progress of his ongoing research (PhD thesis). It is encouraging news that a large number of academic staff attended the seminar and contributed through their active participation in asking questions and making comments.

ICL is planning to increase its research activities in the future. Besides current research activities, it is intended to develop in the following activities:

Year Activities

- 2011 1. Encourage staff to undertake research individually or in a group in the following areas: small business, entrepreneurship, international education, international business or similar fields.
  - 2. Encourage and facilitate staff to attend international conferences and present their research works in these seminars.
  - 3. Encourage staff to publish their research works in journals, books and other forms of publications.

Future Research Plans

- 4. Facilitate staff to conduct primary surveys and equip them with required research tools such as computers, software etc.
- 5. Promote an effective research culture at ICL through encouraging and rewarding research staff for their successful completion of research works.

2012 1. Continue the elements mentioned for 2011.

- 2. Participate in the **Performance-Based Research Fund** (PBRF) census of Tertiary Education Commission (TEC). Staff at ICL will prepare evidence portfolios (EP) for submission to TEC.
- 3. Arrange workshops on research issues at least twice a year

# **Recent International Conference Participation**

Dayal Talukder, Business Lecturer of ICL presented a paper on "Economic Sustainability and Productivity Growth of International Education in New Zealand" in the Seventh International Conference on Environmental, Cultural, Economic, and Social Sustainability which was held on 5-7 January 2011 at the University of Waikato in Hamilton, New Zeal. Dayal found this conference very useful in his research work for the following reasons: the high quality of research papers presented from a diverse range of academic disciplines; intellectually provoking ideas and models on sustainability and good networking opportunities with other researchers.

The abstract of Dayal's paper is presented below.

**Abstract:** This study has investigated total factor productivity (TFP)-growth of New Zealand's international education with a view to analysing its economic sustainability. It has used secondary data to calculate the DEA-based Malmquist productivity index for measuring TFP-growth of international education. It has also used a Log-linear OLS regression model to regress Cobb-Douglas production function for estimating the elasticity of output (GDP contributed by international education). It has found that New Zealand's international education sector experienced a positive TFP-growth during 1999-2004 but the TFP-growth started to decline from 2005 through to 2010. Both TFP and regression models indicated that this sector exhibited, on an average, a decreasing returns to scale during 1999-2010. This sector is not economically sustainable because of current declining trend in TFP-growth caused by technological contraction. Similarly, the output growth is determined by labour not by capital. Government should formulate policy to improve TFP-growth of this sector. The findings of this study may be of interest to researchers, development practitioners and policy makers.
